- 1 The minutes of the 2016 AGM held on 28<sup>th</sup> November 2016 were approved
- Chair's Report for 2017: Jill's report (previously circulated) covered main events in this busy year, and is attached
- Approval of the accounts for the year ending 30.4.17. The accounts were agreed and Jose was thanked for his work. The accounts are attached. The accounts will be submitted to Companies House before Christmas so that there is time to review them before the deadline at the end of January.
- The CIC report for the year ending 30.4.17 was agreed and is attached.
- 5 Membership drive and communications:
  - The web site will be updated by those who are responsible for each section of content.
  - We have 122 official members. The mailing list has been kept on dropbox but we will move it because of new data protection requirements. The details kept are either email addresses or mailing addresses.
- Pattern for future meetings: We will continue to meet on alternate days of the week in 2018 as this is fairer for those who cannot make one of the days. In 2018, those days will be Tuesday and Thursday if the library is available on those days. Jill will check with the library. Jill requested that anyone with ideas for topics, talks, walks, or visits forward them to her.

    meeting but Sufiyo said that she was willing to stand. Chas Warlow had
    said that he was willing to stand down if anyone wanted to serve as a new
    director.
  - All other Directors were re-elected and Sufiyo was elected as a new Director.
  - All officers will continue in their posts for one year.

## 8 AOB:

- Votes of thanks were given to all the Directors, and particularly to Jill Lamb for her work as chair
- We discussed how to make more use of Ham Lands with regularly scheduled monthly walks. This may attract new members and raise awareness of the importance of Ham Lands. Chris is hoping to run regular working parties (e.g. opening up some pathways). We will meet by the Post Office near TESCO at 10:00 on the 2<sup>nd</sup> Saturday of each month starting in January. Sufiyo will get a quote for 10 high visibility jackets with the HUG logo.
- Ham House is letting visitors bring in dogs on a lead as an experiment for 6 weeks.
- Green Screen There are lots of appropriate films but most are expensive (£150-200). Simon is looking into E Films in Farnham who have contacts for cheaper films. He will also look into live streaming to try to cut costs. An A3 poster will be created and Jean will put it on a stand for the Ham Parade Market.
- On Dec. 9<sup>th</sup> at 12:00 The Ham Village Centre will be the site for the launch of a book about Ham from prehistoric times up to Ham House.
